## Open to All 6 to 8 Year Olds

(Players Must be 6 by 4/30/18 and Not Turn 9 before 4/30/18) Mite baseball will give boys and girls the opportunity to participate in a competitive baseball league using coaches or skilled players as pitchers. Games will be four—five innings long played at various Lincoln Park diamonds and will follow normal baseball rules except there will be no standings (win/loss record) kept.

The program is held one night a week, on a rotating basis, either Tuesday, Wednesday, or Thursday nights (6:00 pm) and Saturday's on a rotating basis (10:00 am or 12:00 pm)

All players will be RATED at the end of registration; more information to come.

The cost of the program will be: Residents: \$80.00 (w/o candy), or \$110.00 (with candy)

Non Residents: \$115.00 (w/o candy), or \$145 (with candy)

Players will be given 60 candy bars to sell or eat, if they choose to accept candy.

After candy bar sales, the 9-week program will cost \$50.00 per resident player or \$85.00 per non-resident player.
