



JEFFERSON SUMMER CAMP SWIMMING AT LINCOLN POOL

NEW THIS YEAR: Swimming will be offered as an a-la-carte option and spaces are limited. You must register in advance. Your child must be registered for summer camp for the week/day(s) you are registering them for swimming as part of camp.

We will walk to Lincoln Pool, where we will have instructional swim followed by recreational swim. The pool will be closed to the public during this time.

Swim Testing: Campers must be swim tested in advance. We will offer two dates to choose from the week of June 21; registered participants will receive an email with detailed information once available.

Pool Rules: Listen to & follow directions from camp staff & lifeguards. Stay in assigned section of the pool. No roughhousing in the water. Do not dunk other swimmers. Do not hold anyone under water. No running in the pool area. Diving is permitted in diving areas only in Lincoln Pool. No diving or jumping permitted in Lincoln Wading Pool. Do not splash other pool patrons. Tubes, mats, "water wings," and non-Coast Guard approved floatation devices are not permitted. Failure to abide by these rules will result in removal from the program without refund.

No swimming week 9 (August 23-27)

9:30 AM – 11:00 AM

Campers who are registered for swimming should be dropped off wearing their swimsuit underneath their clothes and be prepared with a towel, undergarments to change into after the pool, plastic bag for wet items, and regular daily camp items. Swimmers must arrive by 8:45 AM. We expect to be back on-site at camp around 11:30 AM.
